I permit your employees to operate the boat. I agree that you are not responsible for loss or damage or loss of use caused by fire, theft, delay in obtaining parts, or any other cause beyond your control. I will pay for and remove the boat from your premises promptly on completion of the work. I acknowledge a possessory lien on the boat for the charges for the "Work Ordered" and related storage or dockage charges, and agree that I have no right of possession of the boat until such charges are paid. If you voluntarily release the boat to me before full payment, I grant you a security interest in the boat for such charges and will pay interest of 18% per year, costs and actual attorney fees incurred to collect same.

I AUTHORIZE THE WORK DESCRIBED ON THE TERMS NOTED ABOVE. I HEREBY AGREE TO PURCHASE THE ABOVE SERVICE AND/OR EQUIPMENT. THIS CONTRACT CONSTITUTES THE ENTIRE AGREEMENT BETWEEN US AND SUPERSEDES AND VOIDS ANY AND ALL VERBAL AGREEMENTS.
